Center Attendance:

\*In order for the deposit tuition to be applied, two conditions must be satisfied: first, an advanced-written notice must be given of discontinuing the program by the 25<sup>th</sup> of the previous month, and second, the student must have remained enrolled for at least six months consecutively. There are no exceptions.

### III. Center Policies

- \_\_\_\_\_ I understand that parent home grading is required. All Answer Books must be returned. A \$5.00 fee will be charged for each lost Answer Book.
- \_\_\_\_\_ I understand that a late fee of \$10 per subject will be applied for payments received after the third (3<sup>rd</sup>) day of the month.
- \_\_\_\_\_ I understand that the Cedar Park Mathology Center reserves the right to withhold worksheets and prevent the students from attending Mathology Center Sessions if the monthly payment is not received by the 10<sup>th</sup> of the month.
- \_\_\_\_\_ I understand that if my child does not take any Mathology material in a given calendar month, but plans to resume Mathology Study within 60 calendar days of absence, then he is considered 'absent' and I do not have to pay tuition for those days. When my child resumes Mathology study, the registration fee is not required. However, the current monthly tuition will be applied at the resumed time.
- \_\_\_\_\_ I understand that if after 60 calendar days of absence, my child is considered a 'discontinued' student. If a 'discontinued' student resumes Mathology study, the registration fee and the current monthly tuition will be applied.
- \_\_\_\_\_ I understand that paid tuition is not refundable or transferable. I understand that in order for the deposit tuition to be applied, two conditions must be satisfied: first, an advanced-written notice must be given of discontinuing the program by the 25<sup>th</sup> of the previous month, and second, my child must have remained enrolled for at least six months consecutively.
